PROJECT SUMMARY– TOWN OF THREE RIVERS

The Town of Three Rivers is inviting qualified contractors to submit quotations for the construction of an accessible pedestrian pathway connecting Sackville Street to Station Street, descending the steep slope below Perrins Villa. A design plan is attached showing the path location, and other details.

The project will include:

- Construction of a durable, accessible pathway
- Installation of handrails for safety and support
- Construction of sitting walls as shown
- Full site remediation, including sodding of disturbed areas
- Integration of two planting beds along the pathway
- Environmental considerations and controls during construction are essential
- All safety considerations must be in place during construction
- Timeline: Start: Spring 2026
- Completion: Before July 1, 2026

Please note: While two flower/planting beds will be incorporated into the construction and are part of this RFP, the planting of grasses and shrubs will be carried out by the Town of Three Rivers and is not part of the contractor's scope.
